Overview

Exa Infrastructure has acquired the Croatian telco Univerzalne Telekomunikacije (Unitel). Unitel has a network consisting of 515km of duct and owned fiber optic cable extending from Zagreb in the north to Ilok in the south, including two border crossings to Serbia and one to Bosnia. Unitel aims to differentiate itself from its competitors by diversifying and growing its network routes to increase connectivity across Europe. This report presents a comprehensive overview of the Croatian optical fibre cables market, the effect of recent high-impact world events on it, and a forecast for the market development in the medium term. Despite a slight decline in growth rate (2013-2014), the market remains stable with moderate concentration, as evidenced by top exporters Slovenia, Poland, Romania, Germany, and Metropolitan France.
